Instructions

The honor of attending a service academy comes with the obligation and commitment to serve in the military for a minimum of five years upon graduation. For more information, please review the page of Frequently Asked Questions for those seeking a Military Academy Nomination.

Members of Congress may nominate candidates for appointment to four of the five U.S. service academies: U.S. Military Academy (USMA), West Point, NY; the U.S. Naval Academy (USNA), Annapolis, MD; the U.S. Air Force Academy (USAFA), Colorado Springs, CO; and the U.S. Merchant Marine Academy (USMMA), Kings Point, NY. The fifth service academy, the U.S. Coast Guard Academy (USCGA), New London, CT, does not require a congressional nomination for appointment. Congressman Latimer may nominate individuals for a total of 15 vacant slots for all the academies. To request a Military Academy Nomination from our office, please complete the form below. Packet Checklist and Requirements

All required information must be provided to my District offices in White Plains or CoOp City, the Bronx no later than Friday, October 10th, 2025.

Each applicant for a nomination must meet the following eligibility requirements as of July 1st of the year of admission to an academy:

- Must be at least 17 years old, but not have passed the 23rd birthday
- Citizenship: Must be a U.S. citizen
- Must be unmarried, not pregnant, and without legal obligation to support children or other dependents
- Must reside within the boundaries of the 16th Congressional District of New York.
- Must meet the medical, physical, and academic requirements of the Academy



Application Process

To consider your request for a nomination, my office requires the following materials:

- Current photo
- High school transcript
- American College Testing Program (ACT) results and/or College Board Scholastic
 Assessment Test (SAT) results
- Resume of extracurricular activities
- An essay stating why you want to attend a service academy (500 words or less)
- **Minimum of three letters of recommendation** from your teachers, counselors, employers, coaches, clergy or scout leaders.

Please submit the entire packet all at once. Once your packet has been reviewed and deemed complete, you will receive written confirmation by email.

To receive a nomination to an Academy, you must have an open admission file at the academy of your choice prior to submitting your packet to Congressman George Latimer's office. You must start an admission file at each academy in which you are interested in attending. If you have not done so, the websites provided below will guide you through the process of completing the preliminary application online.
